5. Correspondence/Communications:

a. LTS Update from Robbie: Tested all skaters, ready for new term.

Erica to help Robbie change the levels in GoMotion.

6. Old Business:

a. Clinic Update: Financials for clinic: -\$493.00 but would be a profit if we charged our club skaters the administration fee. Profit would be \$1,556.80. Our board looks at it as a profit.

- Financials for test sessions: Total expenses was \$5,885.31 loss of -\$3,040.31. Our club skaters pay an administration fee and the partner fee to the actual partners.
- Need to have an off ice coordinator for the day of questions and problem solving, it can't be someone that is a coach on ice.

b. Copier: If you are printing from a jump drive you need to make sure to switch it to black and white. Molly Holmtrom-Bolster is a contact person we can have come in to help us understand the printer better. The printer will only print PDF files. Office planning group to come do a run through with us again on the copier, hoping to have this happen in January.

-Need ink/toner for the MIO printer. May need to order more paper for the copiers also.

c. Christmas Exhibition: Santa was a nice touch. The kids seemed to have fun.

d. Zamboni: Funds are being kept with Junior hockey, the city will not be getting any money until the payment is due. Logo's will stay on forever on the zamboni. \$5,000 is minimum for a logo. They are working on getting people to be able to do the maintenance. The power supply is already in the zamboni bay. Proposal: Give \$5,000 to the zamboni for new funding. Jordan Proposed. 2nd. Lorelei.

e. Bookkeeping Update: Superior Ledger Services, LLC. is \$450/month for bookkeeping. \$80 a month for quick books. One time price of \$450 to convert everything over. All receipts have to be submitted to Hubdoc and uploaded. We would be getting quarterly updates from the LLC. Jenna has offered to reach out to her accountant Mary L. to see what she would have to offer from the bookkeeping side

for us. Will return to this in January. Erica Noe would like time to think through what/if there is anything she would like the bookkeeping company to take over. What do we do with members that don't pay? Or declined credit cards? 1. If they have other cards that are on file we will attempt to charge the other cards on file. 2. Skaters will not be able to get back on the ice until the bill is paid.
